In 2022, four key pieces of environmental legislation pertaining to our ocean, coasts, and Great Lakes share a 50th anniversary:

- National Marine Sanctuaries Act (NMSA),
- Coastal Zone Management Act (CZMA),
- Marine Mammal Protection Act (MMPA), and
- Clean Water Act (CWA).

These acts, along with several others implemented by NOAA, form the foundation for much of the marine and Great Lakes-related conservation for the nation. The "50 Years of Ocean & Coastal Conservation" campaign will highlight NOAA and partner efforts to implement these important acts to achieve these diverse stewardship mandates.
